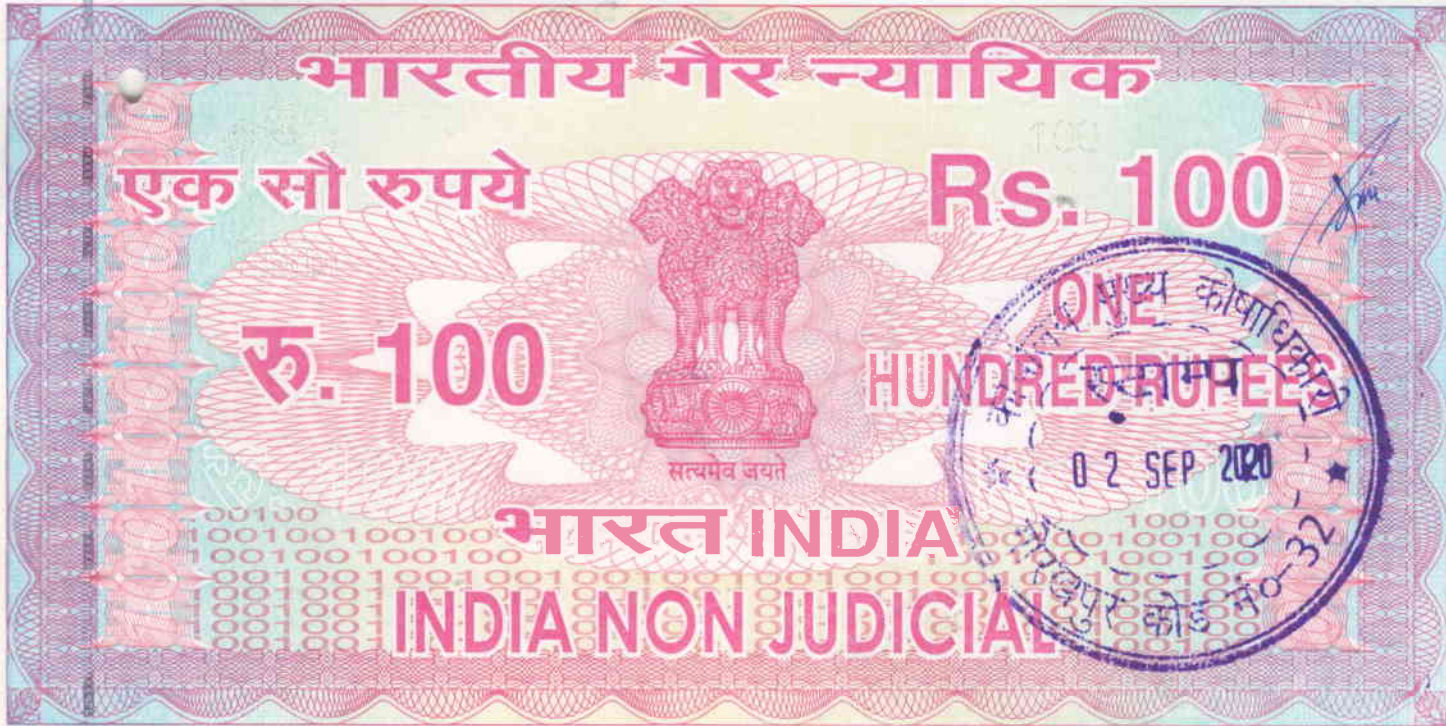


Now this indenture witnesseth as follows,

1. That, in order to effectuate his aforesaid desire, the author of Trust has set apart and handed over to the trustees, a sum of Rs. 5,000 (hereinafter called the "TRUST FUND" which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

2. That the NAME of the trust shall be "**COGITO EDUCATIONAL TRUST**" and its office shall, for the present, be situate at ————1301, Gemini Gardenia, Tara Mandal, Gorakhpur, Uttar Pradesh 273016" and/or at such other place or places as the trustees may decide from time to time in future.

3. That the OBJECTS for which this trust is established are:

(a) To establish, run, support and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.

(b) To establish, run, support and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India for coaching, Guidance, counselling, or vocational training or to grant individual scholarship for Poor, deserving and needy students for elementary and higher education

(c) To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals, meal and other incentives to study, without any distinction as to caste, colour, race, creed or sex.

(d) To provide necessary facilities or to contribute to educational and scientific research development in any place as the trust finds deemed fit.

(e) To arrange and organize lectures, debates, discussions, study tours, conferences, or radio-talks for the advancement of the objects of the Trust.

(f) To organize and run residential educational programme.

(g) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.

- (h) To establish the Educational facilities in the working locality (if required) such as Play way school, Pre nursery school, Primary School or any similar type schooling facility etc.
- (i) To establish Training Centre/ school and allied educational institutions.
- (j) To promote, establish, support, maintain or grant aid to institutions for the promotion of science, literature, music, drama and fine arts, for the preservation of historical monuments and for the research and other institutions, in India, having similar objects for the benefit of the public in general.
- (k) To establish, develop, maintain and grant aid in cash or in kind to multi hospitals for all medical discipline & departments related to medical health services and/or such other similar charitable institutions in India for the benefit and use of the general public
- (l) To arrange and provide medical aid and other assistance necessary for living to the needy people who are incapable or handicapped or mentally/physically retarded and financially unfit.
- (m) To establish, maintain, run or grant aid for the establishment and/or maintenance of parks, gardens, gymnasiums, sports school/institution, sports clubs, dharamshalas and rest houses, for use by public in general.

- (n) To establish, maintain or grant aid to homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons
- (o) To grant relief and assistance to the needy victims during natural calamities such as famine, earth quake, flood, fire, pestilence, etc. and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.
- (p) To grant aid /construct repair and manage the marghats, cemeteries and burial grounds.
- (q) . Create assets and transport facilities to accommodate any of the above activities.
- (r) To grant aid or render assistance to other public charitable trusts or institutions.
- (s) To promote National Integration, Communal Harmony, Universal Brotherhood and Global Peace.
- (t) AND GENERALLY to do in all public, charitable purposes for public benefit without any discrimination of Caste, Creed, Color, Gender, Religion, Faith, Race or any Nationality.
- However in case any of the objects of the Trust are held to be non-charitable within the meaning of section 2 (15) of the Indian Trust Act, or any statutory modification (s) thereof, the Trustee (s) shall not carry out such objectives.

4. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time.
5. That the Trust Fund shall not be applied for any purpose other than those specified in Para 3 hereinabove.
6. That the Trustees shall always maintain proper books of accounts of the Trust as per The Income Tax Act 1961 and which shall be kept at the office of the trust.
7. No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 10, 11, 12 and 13 and 80G of The Income Tax Act 1961 as amended from time to time.
8. The Trustees shall be accountable only for such moneys, stocks, shares and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, default, acts or omissions or commissions of the other trustees, nor of any banker or other person with whom the trust properties or any securities may have been deposited or kept.
9. That for the furtherance of the objects of the trust, the trustees shall have the following powers:
 - (a) To accept donations, contributions, grants, subscription in cash or in kind from any person, company, firm, association, organizations, central government, non - government or semi government agencies, national or funding agencies, family, Trust,

or corporate bodies for furtherance and achievement of the objectives of the Trust with or without conditions.

(b) To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.

(c) To convert and deal with the trust property and/or any investments for the time being.

(d) To invest the Trust Fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments, or in deposits with or loans to any company, bank, firm or any other person, and to alter, vary or transpose such investments, from time to time at the discretion of the trustees.

(e) To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.

(f) To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.

(g) To open account in the name of the Trust, Trustees and/or Institutions run/ conducted by the Trust with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.

(h) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.

(i) To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.

(j) To appoint or make provision for the appointment of any person (including all or any of the Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration and management of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to appoint or provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.

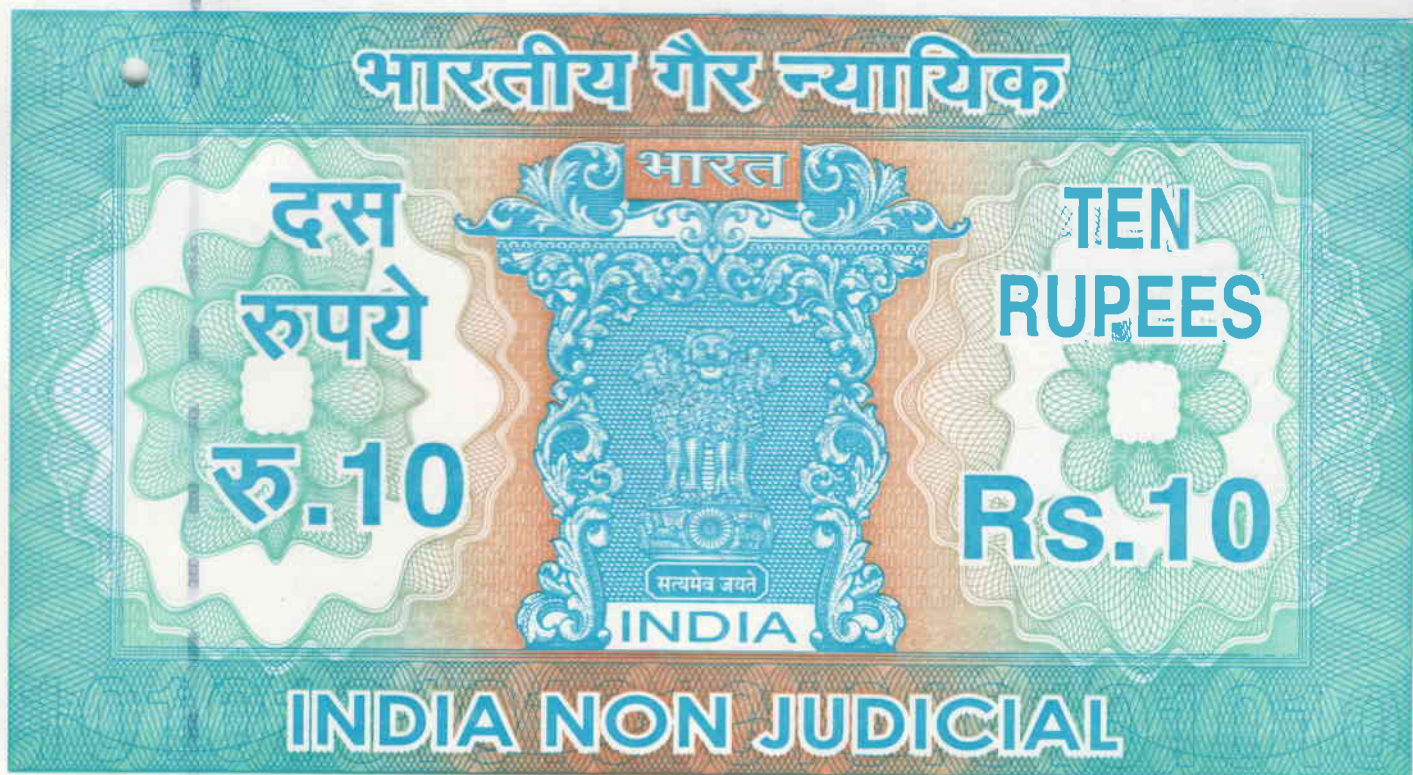
(k) To appoint officers and members of staff for the Trust and to prescribe their condition of service.

(m) To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.

(n) To set apart and/or allocate the whole or a part of the income or the corpus of the trust Fund or part thereof for any of the objects of the Trust.


(o) To join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.



(p) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organisations or Trusts in India which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, Organisation or Trustees to start maintain, or carry out such charitable objects.

(q) To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.

(r) To borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for

the Trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

(s) To authorize person (s) to sign or execute documents on behalf of the Trust.

(t) To grant receipts for aid or donation received.

(u) To acquire land or building on the lease or way of purchase.

(v) To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.

(w) To take over or amalgamate with any other charitable trust, society, association, or institution with similar objects.

(x) To establish, promote, manage, organise or maintain or to assist in establishing, promoting, managing, organising, or maintaining any branch of the Trust or any other Trust or its branch with objects similar to those of this Trust and to promote or carry on the affiliation or amalgamation of such other Trust with this Trust.

(y) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.

(z) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.

(aa) To transfer and hand over the Trust to any other Society, Corporation, Institution, Trust or Organisation on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the Society, Corporation, Institution, Trust or Organisation with the powers, provisions, agreements and declarations, appearing and contained in these presents subject to such modifications as may be necessary and consequent to such transfer of the Trust fund. The Trustees for the time being of these presents shall become discharged from the Trust thereof relating to Trust Funds so transferred.

(ab) To appoint new member or members of Board of Trustees by a resolution and to discharge any of the Trustee, who become bankrupt or acts in any manner prejudicial to the interest or objects of the Trust or is convicted of an offence involving moral turpitude or becomes of unsound mind or is otherwise unfit to continue as Trustee, by resolution passed by simple majority of members present and voting in the meeting of Board of Trustees.

10. The trust will be renewed timely and periodically as per the required law.

11. In the event of dissolution or winding up of the trust the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees but the same shall be transferred to another charitable, religious, trust, society, association or institution whose objects and faiths are similar to those of the trust and which enjoys recognition u/s 80 G of the Income Tax Act 1961 as amended from time to time.

12. That the school run by trust shall adhere to following

(a) One Member of school management committee shall be nominated by the Joint Director of Education.

(b) 10 % quota will reserved for meritorious SC\ST candidates and school will not charge fee more than that prescribed by Uttar Pradesh Madhyamik Shiksha Parishad.

(c) The trust will not seek any aid from State Government and if the school gets affiliated from C.B.S.E./C.I.C.S.E. then the recognition from Uttar Pradesh Madhyamik Shiksha Parishad shall be considered Withdrawn from the date of Commencement and further No More Aid shall be given.

(d) All teaching and Non-Teaching Staff of the institution will be paid salaries and perks as per state government rules.

(e) Service agreement with the employees will be implemented and they will get permissible retirement benefits as per the provisions of aided schools.

(f) All the circulars regulated by the state government will be followed.

(g) All the records will be maintained in specified register.

(h) Any kind of change / amendment will not be permissible/ advisable without prior permission of the administration.

13. The number of the Trustees shall not be less than two and there is no any upper limit for maximum number of trustees.

14. The founder trustees for the time being will be at liberty to appoint additional Trustee for such period or on such terms as to retirement and re-appointment as the trustees for the time being considered proper.

15. A person shall cease to be a Trustee if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, whichever is longer or if he found guilty on account on Misappropriation of Trust fund, Money or any Assets. This clause shall not be applicable to founder trustees.

16. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.

17. In case of occurrence of any vacancy amongst the Trustees because of death, resignation or incapacity of any Trustee or any other cause, a new Trustee may be appointed to fill the Vacancy.

18. The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:-

(a) Two Trustees shall form a quorum for a meeting of the Trustees.

(b) All matters will be decided mutually by the Trustees.

(c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of three fourths of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.

19. The Trustees shall have the power to determine in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoings ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorise the Trustees to spend the income or corpus of the Trust for any purpose not authorised by these presents.

20. The accounting year of the Trust shall be the financial year ending on 31st March every year.

21. The Trust and the Trust funds shall be and irrevocable for all times.

22. It is expressly declared that any part of the Trust property or its income or any accretion thereto can be applied for any purpose outside India for only charitable activities as per Indian Law
